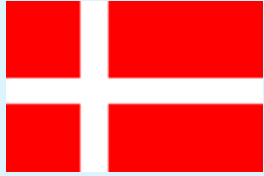




DENMARK



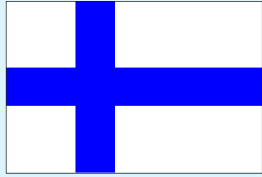
- Budget Analysis of the entire Fire and Rescue Service (state and municipal)
 - Ministry of Defence
 - Ministry of Finance
 - Minimum 7 mill. Euro
 - Steering committee and working team with members from:
 - Ministry of Defence
 - Ministry of Finance
 - Danish Emergency Management Agency
 - Local Government Denmark (THE DANISH ASSOCIATION OF FIRE CHIEFS)
 - Deloitte



DENMARK



- Digital Fire Inspection
 - A partnership between The Danish Association of Fire Chiefs (FKB) and The Danish Institute of Fire and Security Technology (DBI) where the objective of FKB is reducing administrative costs associated with fire inspections, lifting the the quality of the fire inspection and being able to provide data and statistics in order to qualify the fire preventative work
 - 60 municipalities out of 98 have signed an agreement



FINLAND



- **Rescue Act 379/2011**
 - Monitoring plan for fire inspections; quality instead of quantity, focus on risks, chargeable
- **Municipal reform**
 - Fire & Rescue, state or community?
- **New Rescue Commander in Helsinki**
 - No requirement for Fire Officer Diploma only Higher University Diploma
- **Chief Secretary Viljanen, ministry of the interior**
 - Elected assistant city manager in Helsinki

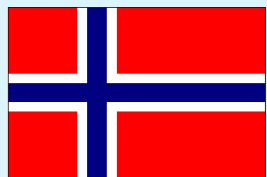

 - In cooperation with the Nordic Countries and the FEU

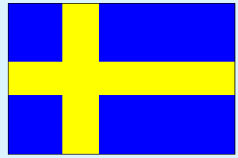




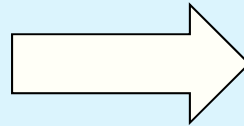
NORWAY



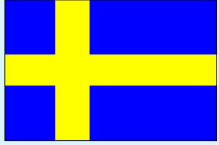
- **TETRA-network operational in the first region in Norway “success” under 22.july 2011.**
- **Pilot project with 112 central.**
- **Government Appointed Committee for Risk Groups have delivered the report.**
- **Government Appointed Committee for Education have delivered the report.**
 - **NBLF have been participants in both committees**
- **ICS: Fire services, civil defense and the Norwegian coastal administration are using ICS**

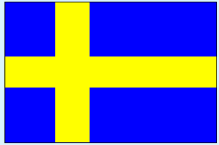
New vision, new goals - new name, new logo !



SWEDEN



- **Equity**
 - The number of women in fire-services are increasing slowly, now 2,4% full-time (4,0% part-time)!
 - More and more efforts are made from the fire-services and the government to increase this number
 - More and more efforts are made by the antagonists to decrease this number
 - The government assigns 6 million euros between 2010-2014,
- **Foam**
 - The use of foam in buildings are increasing
 - Several fires lately have caused terrible consequences
 - Industry are not satisfied when risks are discussed.
 - Fire-services are not satisfied when risks not are treated



SWEDEN



- **National strategy on fire safety**
 - **Vision: No deaths or severe injuries due to fires**
 - **Goals:**
 - **Number of fire injuries and deaths shall be reduced by 1/3 2020**
 - **Better knowledge among citizens**
 - **The number of working smoke-detectors shall be increased**
 - **Methods:**
 - **More and better education**
 - **More and better cooperation buildings**
 - **More research and evaluation.**
